**ACCES-VR:** ACCES-VR assists individuals with disabilities to achieve and maintain employment and to support independent living through training, education, rehabilitation, and career development.

#### Services:

Student and Youth Transition Services: Transition from school to work requires a variety of supports and collaborative efforts among education and workforce programs. No one institution or organization can provide the full range of services that may be required to serve youth with disabilities. However, collaboration and coordinated efforts among education and workforce programs, including vocational rehabilitation, is essential in assisting students with disabilities to make the transition from school to work. By working closely with school districts, the P-12 Office of Special Education and community providers, ACCES-VR helps to ensure that all youth with disabilities are prepared for employment, post-secondary education and community living when they leave school. ACCES-VR can provide a range of services to help eligible individuals reach an employment goal.

#### Process:

- 1. Student makes an informed choice to apply for ACCES -VR
- 2. Student completes application
- 3. VR Counselor determines eligibility
- 4. VR Counselor and student choose an appropriate employment goal
- 5. VR Counselor and student develop an Individualized Plan for Employment (IPE)
- 6. Student acquires skills and supports
- 7. Student gets and keeps a job
- 8. VR Counselor closes case as a SUCCESS!

Eligibility: The student has a disability that creates a barrier to employment; vocational rehabilitation services are required to achieve employment

Children's Care Management: BHSN's Care Management Program consists of Health Home Care Management for Medicaid clients, as well as Non-Medicaid Care Coordination services. We work with youth between the ages of 5 and 21, who have a qualifying mental health diagnosis or other chronic condition that affects their daily functioning. Youth that are referred to our program typically struggle with things such as aggression, depression, anxiety, conduct issues, self-harming, etc. Families that access services are often experiencing stress and crisis within the home, school or community setting. The length of stay within the program is intended to be around 12 months.

The goal of the program is to meet the needs of the youth by developing a team of supports around the family. The team comes together to help the family reach their identified goal.

Eligibility: Client needs to have Medicaid coverage, an SED diagnosis with functional limitations and meet at least one risk factor/appropriateness criteria; Able to provide "non-Medicaid care management" to 2 clients, due to BHSN being a former Target Case Management (TCM) provider under OMH

Referral: The referral process entails submitting the referral form, along with a completed SED verification form and supporting documentation for the SED diagnosis, if available. If the referral source is unable to provide the SED verification &/or supporting documentation, it's very helpful if they can provide an ROI for a service provider who is able to supply that documentation to care management

High Fidelity Wraparound: Wraparound is an evidence-informed team-based planning process intended to provide coordinated, comprehensive, holistic, youth and family-driven care to meet the needs of children, youth, and families who have multiple systems involvement and who experience serious mental or behavioral health challenges. Wraparound uses a team approach and follows a series of steps to help youth and their families meet their needs. It brings together the family, their natural supports and community-based service providers to create and implement a plan that supports the youth and family to achieve their vision for the future. This process focuses on strengths and supports more youth to grow up and thrive in their homes and communities.

Eligibility: Serves youth ages 6 to 21 who: live in Clinton County; have a diagnosed Serious Emotional Disturbance; are involved in behavioral health services and/or multiple child-serving systems; and have emerging or imminent risk of disruption of living situation, childcare, or school placement due to behavioral needs. The youth and family must be willing to participate in the intensive process throughout its four phases

**Services North (bhsn.org)** 

**Respite:** Short-term, temporary care to families in Clinton, Essex and Franklin Counties, NY who do not currently have resources or natural supports to assist in caring for a child with a mental health diagnosis. Unlike typical childcare, respite care is utilized to increase the wellness of the family and prevent unwanted crises by enabling caregivers to take a break. Families who meet eligibility requirements may receive respite for a period of 3 months. Caregiver participation in support and networking meetings is a requirement in order to receive additional respite. Respite services typically do not exceed 6 months in duration.

Eligibility: Families who are raising a child or young adult (ages 3-21) with a mental health diagnosis who are struggling to access natural childcare supports for their child with special needs

Referral: Must be done by a mental health service provider or other professional

Waitlist: Because no eligible family is turned away, a wait list is maintained. The wait time to be matched with a provider varies and priority is given to families with the greatest documented need. BHSN will communicate regularly with families waiting to receive respite and children on our wait list.

Berkshire Farm Center (Together for Youth): Embracing a trauma-informed model of care, Berkshire collaborates with youth and families to help them overcome past traumas, enabling them to live safely and regain control of their lives. Across New York State, Together for Youth offers trauma-informed care exactly where it is needed most: in the homes and communities of these youth and families. When in-home support is not feasible, Together for Youth provides a safe haven through over 550 certified foster homes, community group homes, and both non-secure and secure detention centers.

#### Services:

<u>Stepping Stones:</u> Our mission is to strengthen children and families so they can live safely, independently and with productivity within their home communities. Stepping Stones is an alternative to detention program which offers intensive crisis intervention. The program's goal is to reduce the county's need to place youth into detention facilities.

**Foster Care Program:** At the heart of this program are foster parents, playing a crucial role in providing a stable and loving environment for children while their birth families work toward reunification. We find caring individuals interested in fostering and provide free certification, training and supports to enable these individuals to foster within our program. Once a youth is placed in one of our foster homes, we provide wrap around services: in home clinical program, behavioral specialist, caseworkers, nurses, care managers, etc. We also facilitate the reunification of the families by facilitating family time in a safe environment with the biological families while the youth is living at the foster homes.

Champlain Valley Educational Services (CVES): Champlain Valley Educational Services (CVES), one of 37 BOCES in New York State, is committed to serving our region's many needs. Through the services it offers, CVES accomplishes its goals with the cooperation of its boards of education, school superintendents and other component school district personnel. CVES provides career preparation, special education, instructional services, administrative support and professional development for educators, and is a valuable source of assistance to its 16 component school districts as they strive to keep pace with technical advancements and in stride with economic and social uncertainties and change.

#### Services:

- **6:1:1 Autism Program** This is a 6:1:1 classroom (6 students, 1 teacher, and 1 teaching assistant) for students with a diagnosis of Autism Spectrum Disorder or similar presentation. These children have significant deficits in communication skills and may have significant deficits in adaptive behavior. These children also display challenging behaviors that interfere with learning. Our program uses research-based methodologies such as Applied Behavior Analysis (ABA), Visual Strategies, Picture Exchange Communication Systems (PECS), augmentative communications systems, functional behavioral assessment and Positive Behavior Supports to assist students in attending programs in the least restrictive environment.
- **6:1:1** Intensive (ITSP) Academic/ Behavior Skills Program This is a 6:1:1 classroom (6 students, 1 teacher, and 1 aide) for students with mild to severe emotional disabilities. The child many have borderline to above average cognitive ability, a mental health diagnosis, and display intense challenging behaviors that interfere with learning. These students need special education instruction and mental health clinical services within the school setting. The program provides a broad range of services designed to strengthen individual and family functioning and to prevent children and adolescents from requiring a more restrictive residential environment.
- 8:1:1 Mild to Severe Life Skills Program This is an 8:1:1 classroom (8 students, 1 teacher, and 1 teaching assistant) for students identified by their district Committee on Special Education as meeting the requirements for NYS Alternative Assessment. They may have multiple delays across domains impacting daily functioning, a significant cognitive disability, and significant deficits in communication/language and adaptive behavior.
- 8:1:1 Mild to Severe Academic/Behavior Skills Program This is an 8:1:1 classroom (8 students, 1 teacher, and 1 teaching assistant) for students with mild to severe emotional disabilities. These children have borderline to above average cognitive ability. They may have a mental health diagnosis and display challenging behaviors that interfere with learning.



We are dedicated to providing behavioral health treatment, prevention, education and related support programs to promote the well-being and quality of life for the residents of Clinton County, NY.



#### Services:

**Care Management:** A Health Home is a care management service that connects community and social supports with health care, and organization of medical and behavioral health care. It is a partnership of primary care providers, hospitals, behavioral health organizations and community-based organizations. Care Managers provide a single contact for healthcare and community service needs for a specific population (NYS Medicaid or Medicaid eligible recipients who meet certain criteria, such as having two chronic medical conditions) in order to improve care coordination. It is the hope that all of the caregivers involved with an individual communicate with each other with an eye toward a better focus on their mutual client's varied needs.

Intensive Family Support Program (IFSP): The Intensive Family Support Program (IFSP) is a youth case management program. Our Youth Specialists advocate for, and work with, "at risk" adolescents and families in the community. The program goal is to prevent youths from being placed outside of the home. Youth Specialists facilitate positive experiences for the youth and their family, and engage in a variety of activities and community service projects.



**Neutral Ground Supervised Visitation Program:** The mission of the Neutral Ground Supervised Visitation Program (SVP) is to provide supervised visitation for the noncustodial parent in an atmosphere promoting safe, positive, and productive interactions between children and parents. We work with both the custodial and noncustodial parties, believing that all families have strengths. Our primary focus is to ensure the safety of all children and their family members.

<a href="Supervised Exhange">Supervised Exchange</a> is warranted when one of both the custodial and/or noncustodial parent is unable to transition the child calmly and safely from one to another. In supervised exchange a neutral third party is present to shepherd the transfer of the child/ren from the custodial parent to the noncustodial parent and vice versa. Supervised exchange can also serve as a step down from supervised visitation as a parent' transition to a less structured setting.

Eligibility: To utilize these services a Family Court Visitation order must state that the exchange is to take place at Family Connections

Clinton County C-SPOA: As part of its 2000-2001 New Initiatives, the New York State Office of Mental Health (OMH) has mandated that county mental health administration directly oversee and manage the access to certain Medicaid funded intensive services. These services include Intensive Case Management (ICM), Supportive Case Management (SCM), Home and Community Based Waiver, Family Based Treatment, and adult residential services. Each county is required to maintain Single Point of Access Committees that review all referrals and manage access to these services. Clinton County has two SPOA committees, one for children and one for adults.

Clinton County Department of Probation: The mission of the Clinton County Department of Probation/Alternatives to Incarceration (ATI) is to enhance community safety by providing supervision of adult and juvenile offenders. This is accomplished by serving as a conduit for positive change, overseeing the compliance of probationers mandated with an alternative to incarceration sentence and by compassionately addressing the needs of and providing support to victims of crime. We accomplish our mission through a full range of supervision services, which join with various community based and local service agencies designed to provide innovative programming to prevent crime, re-victimization and delinquency.



Juvenile Delinquent Diversion Program: The Probation Department can provide intervention and services for individuals and families, and be a meaningful resource to the community through the prevention of further delinquency. Probation as an adequate community alternative to placement, reduces the need for Court involvement, lessening the effects of stigmatization, and a cost savings to the community. A Juvenile Delinquent is a person between the ages of 7 and 16, who commits an act which would be a crime if committed by an adult.

In the New York State adult Criminal Justice System, police have direct access to the local District Attorney. In the Juvenile Justice System, by contrast, basically a case may progress from probation intake to the presentment agent and to the Court. The progression is identical regardless of whether the child is detained, taken directly to Court, or released upon issuance of an appearance ticket. The main function of a probation intake is to determine whether cases should be referred to the presentment agent for petition or whether they can be adjusted. Presentment agencies are the local government agencies or authorities responsible for presenting JD petitions for prosecution (FCA §301.2[12]). This function is parallel to the District Attorney's Office in Criminal Courts.

At the beginning of the intake process, the Probation intake worker must first determine that the Family Court has jurisdiction over the case. Probation may also begin to collect information on prior system contacts and request information from schools and other sources. This information is used when evaluating the decision to adjust a case. When the parties are available, the complainant is often interviewed first to establish if he/she has an objection to adjustment. If an objection is made, the case must be referred.

The intake period is sixty days in length. A sixty-day extension can be permitted after application by the Probation Department to the Family Court judge. Decisions must be made regarding adjustment or transfer to the presentment agent within this intake period. When adjustment is not feasible, the case is transferred to the presentment agent. In Clinton County, the presentment agent is the Assistant County Attorney. If there is sufficient evidence to proceed, the case is brought before the Family Court judge. At this time a law guardian, an attorney appointed by the Court to represent the legal interest of the juvenile, is assigned.

<u>Persons in Need of Supervision (PINS):</u> Non-criminal complaints about the behavior of a person under 18 years of age are handled by the Probation Department as a conduit to Family Court. These allegations usually involve patterns of behaviors such as school truancy, running away, late hours, or repeat disobedience to legitimate authority figures such as parents or guardians, school, and foster care agencies.

These matters are commonly referred to as PINS complaints. The individual who makes the complaint is referred to as the "potential complainant." The person against whom the complaint is made is referred to as the "potential respondent." After a preliminary intake review, appropriate cases are assigned to a probation officer and the Department of Social Services (DSS) caseworker for the youth's school district. The probation officer counsels and educates the complainant and respondent regarding PINS diversion procedures and regulations.

The probation officer reviews the referral with an interagency team called the Diversion Committee which makes recommendations for services and programs through the development of a service plan. A referral can be made to the Designated Assessment Service (DAS) for an additional evaluation. The referral is reviewed by the Diversion Committee periodically during the diversion period for case management and monitoring. The probation officer is also an active member of the PINS Diversion Committee which meets with each school district monthly. This interagency team reviews concerns about at-risk youth, facilitates referrals to appropriate agencies, and coordinates services as needed. If a PINS matter can be resolved through conferences and services, the complaint will be adjusted without an appearance before a judge. If conferences and services have not helped improve the situation, the petitioner may be notified that a formal Court action can be filed. The notice that probation sends to the petitioner in such cases must be presented at Court with the petition. Under the law, even when a petition is filed, the Court may return the complaint to intake for further referral services.

If a PINS petition is filed with Family Court, a hearing is scheduled and the respondent is assigned an attorney called a law guardian. If there is a finding that the juvenile is adjudicated a PINS, the Court may place the child on probation under the supervision of the Probation Department. In situations where more structure is needed, the juvenile may be placed in DSS custody for placement in foster care or a residential program.

Child Preventive Services (Until 5<sup>th</sup> Grade): Preventive services are supportive and rehabilitative services provided to children and their families to avert disruption of a family which could result in an out of home placement for the child, to enable a child who has been placed in foster care to be reunited with his or her family at an earlier time than would otherwise be possible, or to reduce the likelihood that a child discharged from foster care will return to such care. Preventive caseworkers are either office based or work within local elementary schools through the Preventive School Partnership Program (PSAP) to assess the need for and provide services. They coordinate referrals and services between the families, schools, Department of Social Services and other community agencies.

Eligibility: Any child that is in need of extra support for themself and/or their caregiver Referral: This can be self done, by a professional, or court mandated. Unless court mandated, these services are all voluntary and require setting goals. Calling is the referral process, there is no paper referral form

Adolescent Preventive Services (After 5<sup>th</sup> Grade): The primary focus of the Adolescent Services Unit is to work with youth and their families who are experiencing difficulty with adolescent issues and are at risk of out of home placement.

Services:

- <u>Preventive Services:</u> Preventive services provide supportive and rehabilitative services to families in an effort to address the parent or child issues creating a risk of out of home placement. Preventive services may be voluntary, or court ordered.
  - Parenting information and resources
  - Assisting parents to better manage their children's behavior
  - Supporting families through stressful times
  - Facilitating family meetings to engage resources and develop plans to help families meet their needs
  - Assisting with issues such as safe housing and transportation

- Persons in Need of Supervision (PINS): A Person in Need of Supervision (PINS) is a child under the age of 18 who is incorrigible, ungovernable, and habitually disobedient and/or is not attending school in accordance with Part 1, Article 65 of the Educational Law. In addition, the child is beyond the lawful control of their parents, guardian, or lawful custodian and requires treatment and supervision beyond what the parent/guardian is able to provide.
  - DSS Adolescent Unit facilitates this
  - Case management services to at-risk youth and families
  - Family/home-based assessments by local DSS
  - Collaboration with the local school districts
  - o In depth assessments by mental health professionals
  - Information and referral to community services

Child Protective Services: Clinton County Child Protective Services (CPS) investigates reports made to the New York State Central Register alleging child abuse or neglect which are alleged to occur in Clinton County. The investigation of a report is an investigative process which includes interviews of children as well as adults, observation of the situation, and information gathering. Its purpose is to protect the child, determine the validity of the allegations, evaluate any condition of abuse or maltreatment that was not reported, and determine the services necessary to ensure the protection of the child as well as reduce the degree of future risk to the child. The investigation includes an evaluation of all children in the home, whether or not they are actually named in the report. CPS strives to alleviate physical abuse, neglect, and sexual abuse of children by their parents and caretakers. Once a child is determined to be safe, an evaluation of the risk of the likelihood of future neglect is made. Based on this assessment, appropriate referrals for services, if any, are made to minimize the risk of future abuse or neglect. When a child is unsafe in their home, placement of the child outside the home will be considered.

Clinton County Youth Court: The Clinton County Youth Court Program is a voluntary diversion program for youth under the age of 18 who are charged for the first time with an offense. Youth Courts accepts violations, misdemeanors, low level felonies as well as noncriminal offences. To be eligible for the program, the youth must admit to the crime. If determined appropriate, a hearing is held in which trained youth, known as Youth Court members, fill the courtroom roles such as defense attorney, prosecuting attorney, judge, clerk/bailiff and jury members. At the end of the hearing, the jury members determine an appropriate sentence for the charged youth based on the information presented. The goal of the program is to prevent delinquency through positive peer influence.

Eligibility: Youth under the age of 18 who are charged for their first time with an offense and have admitted to the offense.

Once trained, youth are part of a pool of approximately 50 Youth Court members. Youth from this pool are assigned to hearings by the Project Coordinator. Members run the courtroom by filling all of the roles including clerk/ bailiff, judge, prosecuting attorney, defense attorney, jury foreperson and juror. Youth must be willing to make a voluntary commitment to the program for one year. Besides participating in hearings, members are required to participate in at least 3 Youth Court sponsored community services activities a year. New member training is typically offered twice a year. The law-related training covers an array of topics and will prepare members to assume the Youth Court roles. Once a member, youth have the opportunity to participate in specialized training to assist with certain roles such as attorney, judge, jury foreperson and clerk/bailiff. Through training and participating in the program members develop: Public speaking and presentation skills; Individual and group decision making skills; An understanding of their civic responsibilities; Knowledge of the criminal and juvenile justice systems.





Office of People with Developmental Disabilities: The New York State Office for People With Developmental Disabilities (OPWDD) is responsible for coordinating services for New Yorkers with developmental disabilities, including intellectual disabilities, cerebral palsy, Down syndrome, autism spectrum disorders, Prader-Willi syndrome and other neurological impairments. It provides services directly and through a network of approximately 500 nonprofit service providing agencies, with about 80 percent of services provided by the private nonprofits and 20 percent provided by state-run services.

### ReadyAdventure:

Ready4Adventure is an outdoor leadership initiative and branch of the Ready4Real program. The program aims to foster a deeper connection with community and nature, enhance environmental stewardship, build confidence in leadership skills, and promote physical, mental, and social well-bring through experimental learning in outdoor settings. Kinship Care: There are thousands of children in the rural areas of New York State being raised by relatives, many of whom are grandparents. Any relative, other than a parent, who is the primary caregiver is providing what is now known as Kinship Care. These arrangements may be either temporary or permanent and are established when the parents are unable or unwilling to care for a child due to illness, addiction, incarceration, violence, or mental health. This care model keeps children in a familiar and nurturing environment and prevents the need for the state to make a foster care placement. Grandparents and other relatives who assume care for these children often lack legal authority to make important decisions. It is important that these Kinship Caregivers consider filing for custody or a kinship placement in order to have the legal right to make decisions and access services for the children in their care. Because there is little or no access to legal assistance for low-income grandparents, most attempt to gain custody by entering the Family Court unrepresented and often they are unsuccessful. The Rural Law Center has entered into a model partnership with the statewide Kinship Navigator program that provides assistance with petition completion and court preparation.

Neuropsychology Clinic & Psychoeducational Services: Our clinic serves as a training site for School Psychology interns and graduate students who work under the supervision of professional staff for the completion of select neuropsychological and psychoeducational evaluations. ### Nexus: A Social Competence Program for Children with Autism Spectrum

It also provides technical assistance and education to families, schools and community agencies. # University of Vermont Health Network: Champlain Valley Physicians Hospital (CVPH) Child and Adolescent Mental Health Unit: Our Child &

Adolescent Inpatient Psychiatry unit has 12 beds, all in private rooms with shared bathrooms. Our program is designed to help children and adolescents ages 6-18 who are having a crisis severe enough to impact their safety and/or the safety of others. We offer a wide variety of group programming that focuses on coping skills, anger management, self-esteem and recognizing alternative ways to deal with feelings and emotions. We also use cognitive behavioral therapy (CBT) and dialectical behavioral therapy (DBT). CVPH contracts with Champlain Valley Educational Services (CVES) to provide a full-time teacher on-site to ensure patients have the right support to maintain and continue their academic studies. This service directly coordinates with the patient's school for consistency and individual needs. The process is as follows: Assessment: Identifying why hospitalization is required; Stabilization: Reducing symptoms; Discharge Planning: Developing a plan to transition out of the hospital.

Youth Advocacy Program (YAP): A national nonprofit advocating for and delivering evidence-based services in homes and communities as a more effective and equitable alternative to youth incarceration and group child welfare, behavioral health, and intellectual disabilities placements.

**YAPWRAP:** Wraparound is an intensive, individualized, holistic care planning and management approach to working with high and complex need youth and families from within their homes and communities. It is deeply rooted in the in the core concepts of wraparound. From the moment we first meet a family through their completion of our programs, families are given "voice and choice"- empowered as equal partners- and services are tailored to their unique needs, strengths, interests and preferences. Wraparound principles also emphasize the importance of individualized, culturally responsive and strength-based services that engage natural supports and occur within the community. YAP's planning process has three components: assessment, a family team meeting, and plan development.

During assessment, we introduce ourselves and the program, and learn more about the family through discussion and by using 4 assessment tools. We also spend time identifying and addressing any immediate safety concerns. Our assessment process empowers youth and families to express their needs, to identify what resources and capacities they have that can assist them, and to identify where there are gaps and how, in fact, we can help them to help themselves. We also reach out to other important stakeholders in the family's life to learn their perspective on the family's need and strengths.

Upon completion of the assessment process, we build a team with the family that will help them develop their plan and support them in achieving their goals. The team includes both formal supports, such as system and service representatives, as well as informal supports, such as extended family, friends, coaches, pastors, etc. We meet with each team member to learn their perspective on the family's strengths and needs and how they can help. Everyone on the team has a role to play.

After meeting with the family team members, we develop an individualized service plan that is shared with all team members and becomes the basis of our work with the family. The plan is frequently reviewed and revised to assess progress and also to include any needs. We also develop a thorough safety plan during this time.

<u>Behavioral Health Services:</u> YAP provides culturally responsive community-based services as an alternative to out-of-home behavioral health care. YAP contracts with mental health systems, managed care organizations and private insurers to provide both fee-for-service and case rate Medicaid reimbursed services. Among YAP's behavioral and mental health services are programs that specialize in working with individuals with autism spectrum disorders, cross-system (justice and child welfare program) youth, and individuals who have experienced trauma.

#### Services:

- Outpatient Services: Services in our outpatient setting provide the full array of behavioral health services mentioned above with the addition of licensed psychologists and psychiatrists. Psychological and Psychiatric evaluations are conducted and detailed assessments completed. Psychiatric services also include medication management when needed.
- In-Home and School-Based Services: We provide intensive individualized service to children in their homes, school and community through our Behavioral Health Services. Though each youth's plan is different, YAP works to build upon the existing strengths of the child and family; develop the young person and family's skills in self-managing areas of need; and connect the family to professional and informal resources in their community that provide support beyond program involvement as needed and desired by the family.
- Intensive Outpatient Programs (IOP)/Day Treatment: IOP services are different from residential inpatient rehab programs and partial hospitalization programs in that treatment is generally part-time. However, the intensive outpatient program is far more comprehensive than traditional outpatient programs that only consist of a few therapy sessions. The IOP consists of numerous weekly therapy sessions at YAP's outpatient facility with experienced counselors (trained in addictions, eating disorders, etc.). These types of programs can be voluntary or imposed by a court.
- YES Waiver (Youth Empowerment Services): The YES Waiver is a Medicaid Home and Community-Based Services Waiver that allows intensive community-based services to assist children and adolescents with severe emotional disturbances to live in the community with their families. Services include Adaptive Aids and Supports, Community Living Supports, Family Supports, Minor Home Modifications, Respite, Transportation, Paraprofessional Services, Specialized Therapies and Transitional Services.

<u>Child Welfare:</u> YAP delivers individualized direct services to families involved in the child welfare system that focus on safety, permanency and well-being. We build on strengths, help to overcome challenges and navigate complicated systems, and most importantly, develop positive connections within the family and between them and the community that are critical for long-term success.



- Improving Families: Youth Advocate Programs, Inc. (YAP) provides intensive services to the highest need families involved with or at risk of becoming involved with Child Protective Services through our Improving Families Program. The program is an inhome, in-community service that strengthens the ability of parents to safely care for their child(ren) by using the "teachable moments" approach. YAP staff assist parent(s) in the day-to-day activities of the home to find natural opportunities to model and offer coaching on healthy parenting and household management strategies. The Improving Families Program reduces the risk of out of home placement, evidenced by a reduction in the number and severity of child protective reports. It also effectively prepares parents for the early return of their child(ren) from foster care or residential settings.
- <u>Reunification Program:</u> Youth Advocate Programs, Inc. (YAP) provides intensive services
  to safely reunify families who have children in residential or other placement outside of
  their home. An extensive assessment is provided in collaboration with the placement
  facility/location, the local social service department, the family, community partners
  and local law enforcement. The proactive planning includes:
  - Detailed safety plans
  - Supervision schedules
  - Securing educational services
  - Exploration of employment and vocational options as appropriate
  - o Referrals to appropriate services such as mental health and substance abuse
  - Extensive work with family, youth and referring authority to find a viable discharge option if there is no current option

Once the plan is approved by the family and the local Department of Social Services (LDSS), a discharge date is established for the youth. Upon discharge, the plan is implemented and intensive family and community work begins.

- Family Identification and Permanency Solutions: Youth Advocate Programs' (YAP)
  Family Identification and Permanency Solutions (FIPS) services are designed to identify and engage permanency options for youth who are lingering in out of home care who have no identified viable discharge options. Incorporating elements of the National Institute for Permanent Family Connectedness' Family Finding model, YAP staff employ our hallmark never give up approach to identify a resource for each youth, whether it is a long lost family member or a person that shows interest in the youth and would be willing to become a resource otherwise known as "fictive kin."
- <u>Substance Use Recovery:</u> YAP provides intensive, family-focused interventions designed to support the safety and well-being of children whose parental substance use presents a significant risk of harm through in home and community services.
  - Prevention of Placement: YAP services work with parents whose children are at risk of placement due to their substance use to eliminate or reduce their risks while positively connecting the parent with peer supports in the community.
  - Reunification from Placement: YAP services work with parents to prepare for successful reunification from placement to the home, and remain within the home as a support during the transition period to help prevent relapse and promote healthy attachment and relationships.
  - Family Finding: YAP engages in family finding as short and long-term solutions for children whose parental substance use may require removal from the home while also working to safely preserve family attachments and promote parental recovery.
- Transition Age Youth: YAP views transition age youth as "at promise," or full of untapped potential that needs to be cultivated, supported and enabled through purposeful efforts to create opportunities, meet needs, and to develop meaningful, relevant skills and supports. YAP uses frameworks from the Harvard University's Center for the Developing Child and the Full Frame Initiative's interconnected domains of wellbeing in conjunction with our core model which includes elements of wraparound planning, case management, mentoring and positive youth development.

Intellectual and Developmental Disabilities: Since 1997, YAP has been working with children and adults with developmental disabilities and autism spectrum disorders. We have worked with self-advocates and their families, as well as experts from various professional backgrounds, to develop a model for working with individuals with developmental disabilities and spectrum disorders that focuses on the importance of relationships, meaningful decision-making, self-determination and inclusion.

**Ages 0-3:** YAP offers services to infants and toddlers who have special needs due to developmental delays or disabilities. Services engage the child's family to strengthen their ability to support the child's resilience and development through training, coaching, modeling and consultation within the home and community.

<u>Individuals Dually Diagnosed with Mental Health Diagnosis:</u> YAP provides home and community support to individuals who are dually diagnosed with developmental disabilities and mental health diagnoses. Direct support to caregivers is available through planned short-term relief. These respite services are provided to both children and adults in their homes and communities

Developmental Disabilities: YAP provides community-based services to enhance the health and welfare of children and adults with developmental disabilities, such as physical disabilities, intellectual disabilities or those with traumatic brain injury. Caring and supportive staff assist individuals in acquiring, maintaining and improving self-help, domestic, socialization, employment and adaptive skills. YAP also provides supportive services to parents with intellectual disabilities to help them raise their children with confidence Autism Spectrum: YAP specializes in serving children, youth and adults diagnosed with autism spectrum disorders, providing them with individualized supports and skill development to promote their inclusion in typical community settings. Additional services include respite, training, and individualized consultation for caregivers. Training and consultation in a variety of formats, from webinars and live workshops to conference calls, is also available to other community stakeholders.

## **Clinton County Children's Care Management Agencies:**

### 1) Behavioral Health Services North, BHSN

- a. BHSN's Care Management Program consists of Health Home Care Management for Medicaid clients, as well as Non-Medicaid Care Coordination services. We work with youth between the ages of 5 and 21, who have a qualifying mental health diagnosis or other chronic condition that affects their daily functioning. Youth that are referred to our program typically struggle with things such as aggression, depression, anxiety, conduct issues, self-harming, etc. Families that access services are often experiencing stress and crisis within the home, school or community setting.
- b. The length of stay within the program is intended to be around 12 months.
- c. The goal of the program is to meet the needs of the youth by developing a team of supports around the family. The team comes together to help the family reach their identified goal.
- d. <u>Eligibility:</u> Client needs to have Medicaid coverage, a SED diagnosis with functional limitations and meet at least one risk factor/appropriateness criteria.
- e. <u>Referral:</u> Fill out CHHUNY referral form, utilize C-SPOA, or use the BHSN specific referral form.

### **II) Champlain Valley Family Center, CVFC**

- a. A Health Home is a care management service that connects community and social supports with health care, and organization of medical and behavioral health care. It is a partnership of primary care providers, hospitals, behavioral health organizations and community-based organizations. Care Managers provide a single contact for healthcare and community service needs for a specific population (NYS Medicaid or Medicaid eligible recipients who meet certain criteria, such as having two chronic medical conditions) in order to improve care coordination. It is the hope that all of the caregivers involved with an individual communicate with each other with an eye toward a better focus on their mutual client's varied needs.
- b. <u>Eligibility:</u> Client needs to have Medicaid coverage and at least two chronic conditions (Mental Health, SED, Substance Use, Asthma, Diabetes, Heart Disease, BMI at or above 85th percentile, HIV/AIDS, Complex Trauma).

### **III)** Families First

#### Breastfeeding Support and Counseling

Breastfeeding provides babies security, love and food all at once! The Clinton County WIC Program promotes and supports breastfeeding as the normal way of providing infants with the nutrition they need for healthy growth and development. From our supportive staff and Peer Counselor, to our pump program and enhanced packages, we celebrate breastfeeding. WIC currently employs three IBCLC's (International Board Certified Lactation Consultants) and one CLC's (Certified Lactation Consultants).



#### The WIC Peer Counselor Program

As a new mom, it is hard to know what to expect. You may feel a little nervous about nursing or have many questions. A Peer Counselor is here to help! Our Peer Counselors have personal experience with breastfeeding and are trained to provide information and support. You will find these friendly moms available to meet with you during some clinic hours, by appointment or on the phone, evening and weakeneds.

The Peer Counseling program is offered free to all WIC families and a peer counselor can be requested at any time during your pregnancy or while breastfeeding.

### The WIC Breast Pump Program

Our WIC staff and Breastfeeding Coordinator can help with questions or concerns about breastfeeding and, if needed, help you obtain a breast pump or nursing aid at no cost. We follow NYS established guidelines to determine which of a variety of pumps will best meet the needs of the mother and baby. The guidelines consider factors such as a mother's plan for exclusively breastfeeding and the number of hours spent at work or school.
