**District: Town of Beekmantown**

*On June 17, 2024, the Town of Beekmantown Town Board adopted a resolution to reduce the number of Town Justices from two, to one. The vote was five to zero in favor.*

*Total defendants in 2018: 686*

*Total defendants in 2019: 634*

*2020 and 2021 = Covid-19 years not included*

*Total defendants in 2022: 333*

*Total defendants in 2023: 263*

*There was a 61% reduction in total number of defendants from 2018 to 2023.*

*With only 39% of the number of defendants over the course of six years, the Town Board decided the workload did not support the necessity of a second Town Justice. Considering that one of the Town Justice's term was ending on December 31, 2024, the Town Board decided the change was justified and would not have an impact on reducing a Town Justice in mid-term.*

*A petition was drafted and circulated by town residents, obtaining the required signatures to challenge the resolution. The petition was submitted on 7/15/2024. After verification of names, signatures and residency, the Town Clerk certified and filed the petition on 7/23/2024.*

*The petition calls for reinstatement of the second Town Justice.*

*The 2024 salary for each Town Justice is: \$18,717.00.*

**A "YES" vote would be in support of the petition, reinstating the second Town Justice and would incur an additional salary at the 2025 rate. This would be added on top of the tax levy.**

**A "NO" vote would keep the Town justice position at one.**
