Deputy County Administrator Kim Kinblom conducted roll call. All Legislators were present.

Ms. Kinblom read the title of Resolution #1, "Appointing Chairperson of the County Legislature for 2025."

Resolution #6, "Appointing Assistant County Attorney for 2025." Legislator Hall offered the name of Gary L. Favro, seconded by Legislator Peryea. Carried (9-0-0-1).

Resolution #7, "Appointing Administrator of Indigent Defendants for 2025." Legislator Hall offered the name of Justin R. Meyer, seconded by Legislator Timmons. Legislator Hall stated Mr. Meyer has done a great job and goes above and beyond when asked. Carried (9-0-0-1).

Legislator Hall motioned to Waive Rule 13.2, seconded by Legislator Kretser. Carried (9-0-0-1).

Resolution #8, "Appointing Off Track Betting (OTB) Director for 2025." Legislator Hall offered the name of Sherm Hamel, seconded by Legislator Timmons. Carried (9-0-0-1). Mr. Zurlo stated he would begin the process of the OTB appointment Friday, January 3, 2025.
