Stenographer's minutes of the Regular Session of the Clinton County Legislature held Wednesday, June 12, 2024 in the Legislative Chambers, 137 Margaret Street, Plattsburgh, New York.

Chairperson Henry called the meeting to order at 5:15 p.m.

Michael Zurlo, the County Administrator, conducted roll call. Legislator Hall asked to be excused.

Legislator Randall motioned to accept the minutes of the May 22, 2024 Regular Session, seconded by Legislator Waldron. Carried (9-0-1).

Chairperson Henry stated each year, the Off Track Betting Committee awards two scholarships; one to a student attending SUNY Plattsburgh and one to a student attending Clinton Community College. The students selected must have a grade point average of at least 85 percent, have demonstrated leadership abilities, especially involvement in community activities and have taken part in a minimum of two extra-curricular activities, with at least one being non-sports related. Chairperson Henry congratulated the SUNY Plattsburgh recipient, Kassidy Turek, of Chazy Central Rural School, and invited Kassidy to the podium to receive her award.

During her high school career, Kassidy has worked hard both academically and athletically. Kassidy was a member of the Varsity Girls Soccer, Basketball and Softball Teams. She was also a member of High School Band, Leo Club, Ushers Club, North Country Model UN and National Honor Society.

Kassidy will graduate 1st in her class from Chazy Central Rural School on Friday, June 28th and will be attending SUNY Plattsburgh in the fall to major in Elementary Education.

Aiden Dominic was the recipient of the Clinton Community College award. He was unable to attend tonight's Regular Session but Legislator Castine will bring his award to the school later this week.

Chairperson Henry asked if anyone wished to address the Legislature.

Debbie Hicks of Champlain, New York praised Jennifer Jewett's dedicated efforts to see the proposed dog tethering law enacted. She doesn't understand why some members of the Legislature are not on board with this cause.

Jennifer Jewett, of 11109 State Route 9, Champlain, New York spoke about the eleven-year-old husky in Mooers, New York that recently passed and how the animal spent its entire life chained up. She asked the Legislature to pass the law to help the animals.

There being no one else who wished to address the Legislature, Chairperson Henry moved onto the Committee Reports.

Buildings and Grounds Committee - Legislator Bezio

Legislator Bezio stated the Buildings and Grounds Committee met on Monday, June 10th.

James Cleveland, the Superintendent of Buildings and Grounds, was present to discuss several resolutions including, "Authorizing the Purchasing Agent to Solicit Bids for the Emergency Services Boiler Replacement Project," "Authorizing the Purchasing Agent to Solicit Bids for the Surrogate

Building Exterior Renovation Project," "Authorizing the Purchasing Agent to Solicit Bids for the Old Court House Window Replacement Project" and "Authorizing the Purchasing Agent to Solicit Bids for the Mental Health Exterior Paint Project." He also provided an update on the Government Center Brick Project, the Wendel Energy Services, LLC Project and the American Rescue Plan Act (ARPA) Projects.

Children and Family Services Committee - Legislator Peryea

David Marcoux, the Director of Probation, was also present to discuss several resolutions including, "Authorizing Payment of Membership Dues" and "Authorizing Pre-Trial Services Grant Acceptance."

Jami Rock, the Administrative Assistant at the Child Advocacy Center (CAC), was present to discuss several resolutions including, "Authorizing Contract with Essex County" and "Authorizing Outof-State Travel."

Coroner Chad Deans continued discussion on the Mortuary Cooler and the potential Multi-County Purchase and Use of Drug/Toxicology Testing Equipment.

LCT would like to get the Marina back to proper order and add a large breakwater. The Legislative Board unanimously approved the letter.

Legislator Peryea motioned to enter into Executive Session at 6:00 p.m., seconded by Legislator Hughes. Carried (9-0-1).

Legislator Waldron motioned to exit Executive Session at 6:45 p.m., seconded by Legislator Hughes. Carried (9-0-1).

There being no further business to come before the Legislature, Legislator Bezio motioned to adjourn the meeting at 6:45 p.m., seconded by Legislator Kretser. Carried (9-0-1).
