Comments: In reviewing the project the Planning Board would like to encourage the Town to ensure that the applicant is addressing the following concerns:

- Ensure that the applicant addresses the proper disposal of waste oils and fluids. Particularly that an adequately sized oil-water separator is to be installed on the premises. Additionally the Town should ensure that the applicant has a plan for the proper storage and disposal of all vehicle fluids, as well as other cleaning/miscellaneous chemicals.
- The Town should ensure that the applicant is addressing the plan for storage of on-site vehicles, and the number of vehicles that are planning to be stored on site. If such vehicles are to be permitted they should be located in a screened in area from the adjacent roads and neighboring properties. This is of particular concern if there are junk vehicles, and vehicles being used for parts.
- If any vehicles are to be placed on the site for sale, they should be given a designated space and limited in number.
- Ensure that parking for customers is addressed, and no parking should occur along the side of the road.
- Applicant should indicate what outdoor lighting is being proposed and ensure that it will not disturb neighboring properties.
- Applicant should address the plan for storage of vehicle parts, tires awaiting disposal, and the location of on-sire dumpster/trash.
- Town is encouraged to gather information about the permits being obtained NYSDEC/NYSDMV to operate this business.
