NARRATIVE: On March 19th 2026, a report was made to Clinton County Sheriff Deputies of a domestic incident located at 15 Commodore Thomas Macdonough Hwy, the Rip Van Winkle Motel, located in the Town of Plattsburgh. Upon arrival of Deputies it was determined through police investigation and witnesses on scene that Brian Wilson was involved in a Domestic Dispute. It is alleged that during the Domestic Dispute, Wilson prevented the victim from leaving the scene while threatening her with a knife. It is also alleged that two juvenile children aged 1 year old and 4 months old were present during this encounter. It is also alleged that Wilson intentionally concealed the knife used in the commission of the crime within his residence. Wilson also intentionally obstructed Officer's from checking the wellbeing of the victim who was screaming for help. After the commission of the alleged offenses, Wilson was taken into custody by Clinton County Sheriff's Deputies. It is alleged that when Deputies attempted to take Wilson into custody

he physically resisted arrest and attempted to obtain bear spray to use against the Deputies.

DISPOSITION: Wilson was arrested on scene and transported to the Clinton County Sheriff's Office where he was processed on the above stated charges. Wilson was subsequently arraigned in the Town of Plattsburgh Court. Following Wilson's arraignment, Wilson was remanded to the custody of the Clinton County Correctional Facility in lieu of \$10,000.00 USD Cash Bail, \$20,000.00 USD Secured Bond or \$100,000.00 USD Partially Secured Bond. Wilson is set to appear in the Town Of Plattsburgh at a later date to face the allegations.
